**1. Review and Approval of last Steering Committee Call Notes**

**Discussion:**

**2. Update on launch of Decade of Accountability for the SDGs**

**Discussion:**

The TAP Secretariat updated the Committee on the new Decade of Accountability for the SDGs campaign that was launched Wednesday May 27. With the launch came the release of the “Global SDG Accountability Survey which will remain open through the end of July (and likely extended) and will be promoted regularly.

The survey, and other ways of engagement found on the website [www.sdgaccountability.org/decade](http://www.sdgaccountability.org/decade), will be heavily promoted through HLPF and leading up to the launch of the “Global Accountability Report” around the time of UN GA opening in September.

Responding to CSPPS’s question on how many people have since engaged, the secretariat noted that about two dozen respondents have completed the survey as well as committed to the campaign by becoming an “SDG Accountability Champion.” The survey is longer than tradition TAP surveys which partly explains the lower rate of response. It was noted that the specific methods of engagement need to be promoted more heavily and with more effective language going forward.

#### **FOLLOW-UP**

- **The secretariat will continue to promote these methods of engagement until the launch of the “Global Accountability Report” launch in September**
- **Steering Committee members should share the campaign and the survey with their network and on their platforms to get as much engagement as possible.**
- **The Secretariat will update the Steering Committee on the virtual event and blog post series that are under consideration in the lead up to HLPF**

### **3. Review of TAP 2020 HLPF Side-Events**

#### **Discussion:**

The chair moved to the next agenda item: the tentative list of side events for the virtual HLPF 2020. The secretariat listed the tentative plans for side events - most of which are being led by TAP’s partners (ie passive engagement) except for the Decade of Accountability Event.

#### **DISCUSSION:**

The chair noted that the Membership engagement survey was sent to the network membership this past week.

The survey, along with other membership opportunities, will be promoted next week on social media as well as through the new newsletter and the membership engagement portal webpage -- an online platform regularly updated with information on opportunities. These opportunities include: blog submissions, spotlight reporting, working group sign ups (COVID-19 taskforce and Spotlight reporting taskforce).

It was suggested to share the results of the early responses of the survey. However, it might result in biased responses. However, insight and prompts shared on the newsletter may spur more respondents.

The secretariat also updated the committee on the discussions had on future webinar topics—the next of which will be hosted with Transparency International on the topic of Corruption and COVID-19. Going forward, there will also be planning of on the Decade of Accountability webinar possibly in July. The secretariat noted that brainstorming/mapping out on future webinars with potential TAP co-hosts is needed going forward leading up to HLPF.

The Steering Committee members agreed that the secretariat should take the responsibility of reviewing blogs to post. The blog posts will also include a disclaimer for all the blog posts and the blog portal in general. A more formal schedule will developed as submissions are received, but tentatively, blogs will be posted on a monthly basis.

#### **FOLLOW-UP**

- Concrete information on upcoming membership engagement opportunities (including the survey, the call for blogs, the two working group sign ups, and the upcoming webinar on Corruption and COVID-19) will also be shared with the network through the launch of the newsletter and publishing the membership portal online early next week
- The secretariat will keep the committee updated on the development of the next webinars set between now and through HLPF with potential TAP partner co-hosts.

### **5. Partnership Updates**

#### **Discussion:**

In regards to the partnership UNDP for the Post-VNR resource, the secretariat updated the committee that the first draft is currently in the process of being finalized. The current contract

with UNDP goes through the end July and will include the end of this draft as well as subsequent consultations and revisions prior to the launch in September. Going forward, the next steps are preparing for the upcoming launch. UNDP has expressed interest in extending the contract past July and beyond the delivery of the resource draft—for potentially a year-long partnership. This allows for an exploration of different ways of collaboration in the future. If the current rate of funding holds, it would be 100,000 dollars for the next year. The secretariat will send the first draft of the Post-VNR resource to the Steering Committee as soon as it becomes available.

#### **FOLLOW-UP**

- The secretariat will send the first draft of the Post-VNR resource to the Steering Committee as soon as it becomes available.
- Next week, the Secretariat will draft an initial proposal for a long-term contract with UNDP that includes budgets and workplans that will be sent to Steering Committee members and Proteus Fund for review and before sending to UNDP.
- Over the next weeks, the secretariat will begin preparations for the launch of the Post-VNR resource in September.
