DECISIONS TAKEN FROM CONFERENCE CALL:

Agenda Item 1: Working methods of the TAP Network Steering Committee

Decision 1.1: Members of the TAP Network Steering Committee will elect two co-chairs with one member from the Global North and Global South.

Decision 1.2: Members of the TAP Network Steering Committee will have conference calls bi-weekly – every two weeks. The Steering Committee or the TAP Coordinators can convene conference calls on an ad hoc basis as they are required, in between these bi-weekly calls.

Decision 1.3: The TAP Network Steering Committee will strive to reach consensus in its decision-making processes, but if needed, members of the Steering Committee will conduct an open voting process to reach a decision on items. Voting on these issues will be decided with a majority vote, consisting of 3 or more votes.

Decision 1.4: The TAP Network Steering Committee will provide meeting minutes with decisions taken to the wider TAP Network, which will be available on the TAP Network website.

Decision 1.5: The TAP Network Steering Committee will select speakers to represent the TAP Network, as opportunities arise. The TAP Coordinators will facilitate a nomination process to identify these potential speakers, and provide the Steering Committee with relevant information to make their decisions.

Decision 1.6: Each member of the TAP Network Steering Committee shall select a substitute representative to represent their organization if the focal point cannot attend Steering Committee meetings.
